Students' interest in learning at the beginning of corona 2019 - 2020 children did not have an interest in learning, thus there was 50% face-to-face, student learning interest slowly increased and after 100% face-to-face, much different from the covid period compared to the pre-covid period. greatly decreased even though it was 100%, not only decreased interest in learning but student discipline also decreased.
